I. APPROVAL OF AGENDA:

- 1. Trustee Richeson made a motion to approve minutes 24-15 for August 7, 2024. Trustee Schmidt seconds. Roll call vote, all in favor, motion passed.
- 2. Trustee Richeson made a motion to approve the agenda 24-16 for August 21, 2024. Trustee Schmidt seconds. Roll call vote, all in favor, motion passed.

II. COMMUNICATIONS:

1. Mayor stated that the Village received an invitation to a ribbon cutting & open house DeMange Farm on September 13, 2024.

IV. TREASURER REPORT:

June and July Report minutes

In June, net assets were \$1.1 M. Property tax revenues came in and there was a small amount received. There was a deficit of \$6K for the month. There is a year-to-date deficit of \$32 K. There were legal fees in Ord and Fin of \$2700 for work on special use permit. In the police fund there was an expenditure of \$3600 for dispatching. There was a \$5200 expenditure in the water for periodic maintenance of the water tower.

In July net assets are \$1.2 mil due to larger Property Tax revenues. For the month of July, there was a surplus of almost \$97 K. For the first 4 months there was a surplus of \$64K. The auditor's fee of \$9500 was paid. That's up from \$8300 from last year or almost 14%. There was an atypically large professional services expenditures in the sewer fund. An engineering firm was paid for services in connection to relining sewer lines.

- A. COMMUNITY DEVELOPMENT/HEALTH:
 - 1. Trustee Elliott was not present. Nothing to report.
- B. WATER AND SEWER:
 - 1. Trustee Ashoff had nothing to report.
- C. POLICE:
 - 1. Trustee Ross had nothing to report.
 - 2. Chief Kukla reported that school has started, and Justin is back as the SRO. The department purchased supplies for Justin to teach the DARE program at St Jacob and

Marine elementary schools. The Chief reported that in the last month they have issued twenty-eight tickets and collected \$1214 in fees and fines.

D. ORDINANCE AND FINANCE:

- 1. Trustee Gavlick asks that the raffle license ordinance be removed from the agenda.
- 2. Fence ordinance tabled to next meeting.
- Trustee Gavlick made a motion to hire JD Kirkpatrick from part-time to full-time at the rate of \$23.50 per hour. Trustee Ashoff second. Roll call vote, all in favor, motion passed.
- 4. Discussion ensued as to the trustee and mayor's yearly pay. Trustee Gavlick made a motion to have our attorney draft an amended ordinance to raise the trustee pay to \$100 per meeting and for special meetings the rate would be \$150 per meeting. The mayor's annual pay to \$7500 per year. Trustee Richeson second. Roll call vote, all in favor, motion passed.
