ORDINANCE NUMBER 19-608

**AN ORDINANCE AMENDING
CHAPTER 24 OF THE REVISED CODE OF ORDINANCES
REGARDING THE MOTOR VEHICLE CODE**

WHEREAS, The Village of St. Jacob, Illinois, has the authority to regulate the parking and operation of motor vehicles within the corporate limits of the Village of St. Jacob;

WHEREAS, it is necessary, desirable and in the public interest and in the interests of safety that the Village is free of derelict, inoperable or abandoned vehicles; and

WHEREAS, the Village desires to increase penalties for violations of Parking Rules and relating to Abandoned Vehicles, among other amendments; and

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1: Section 24-6-1 and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Parking Rules, are amended by deleting from the original language and inserting in lieu thereof the following language:

24-6-1. Time Limit Parking. It shall be unlawful to park any vehicle, trailer, or camper on any Village Street, Lane or public right of way in excess of five consecutive days.

SECTION 2: Section 24-6-3D shall be added to Parking Rules and shall state as follows:

Section 24-6-3D Parking on Private Property. No motor vehicle shall be parked on any front, side, or rear yard except on an approved driveway.

SECTION 3: Section 24-6-5 and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Parking Rules, are amended only by adding the following to the end of the existing said section:

Any vehicle towed for a violation of the Parking Rules shall be removed by the Village or any private service as directed by the Village and held until a release fee is paid by the owner to the Village of no less than \$75.00, in addition to any fees as the tow service may charge, in addition to any other fines as provided herein.

SECTION 4: Section 24-6-6 and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Parking Rules, are amended only by increasing the fine for each such offence to \$25.00.

SECTION 5: Section 24-7-1 and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Abandoned Vehicles, are amended only by replacing the definition of “Abandoned Vehicle” for the following:

“Abandoned Vehicle” shall mean all motor vehicles or other vehicles in a state of disrepair, rendering the vehicle incapable of being driven in its condition; any motor vehicle that is currently unregistered or with a registration having been expired for a period of time greater than six months, any motor vehicle that the owner has attempted to convert to a storage structure or living quarters, or any motor vehicle or other vehicle that has not been moved or used for five (5) consecutive days or more and is apparently deserted. This shall not apply to any vehicle that is stored within a garage or building that is completely enclosed.

SECTION 6: Section 24-7-2B and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Abandoned Vehicles, is amended only to add the following to the end of section 24-7-2B as presently drafted:

For the purpose of removing a vehicle as permitted herein the Police Department may enter upon private property, provided that the entry shall not be made into any structure that is completely enclosed.

SECTION 7: Section 24-7-2C and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Abandoned Vehicles, are amended only by lowering the number of days the Village must wait before towing an abandoned vehicle on private property from seven (7) to five (5) days.

SECTION 8: Section 24-7-14 and any amendments, of the Revised Code of Ordinances of the Village of St. Jacob regarding Abandoned Vehicles, are amended by increasing the fine as indicated in 24-7-14(B) for each such offence to \$150.00; and by deleting 24-7-14(C) and replacing it with the following:

24-7-14(C) shall be required by the Court to make a disposition on the abandoned or unclaimed vehicle and pay all towing and storage charges pursuant to this article, which shall be no less than \$150.00 or otherwise as the tow service may charge.


SECTION 9: This ordinance shall become effective upon its passage, approval as required by law. Any other ordinances in conflict with the amendments made herein shall be amended to conform thereto.

ADOPTED this 20th day of November 2019, pursuant to a roll call vote by Board of Trustees of the Village of St. Jacob, Madison County, Illinois.


