**ORDINANCE NUMBER 26-643**  
**AN ORDINANCE AMENDING CHAPTER 38 OF THE REVISED CODE OF**  
**ORDINANCES REGARDING WATER AND SEWER RATES**

**WHEREAS**, The Village Board of Trustees for St. Jacob, Illinois charges rates for water and sewer usage both within and outside of the Village of St. Jacob that are now increasing, and

**WHEREAS**, it has been the decision of the Board of Trustees to amend its water and sewer rates to pass the increasing rates on to the users of water and sewer services of St. Jacob, and

**NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ST. JACOB, STATE OF ILLINOIS, AS FOLLOWS:**

**SECTION 1:** Section 38-4-11 and any amendments of the Revised Code of Ordinances of the Village of St. Jacob setting the water and sewer rates charged to users both inside and outside of the corporate limits of St. Jacob, Illinois are amended by deleting there from the original language and inserting in lieu thereof the following language:

---

**38-4-11 WATER AND SEWER RATES.** There shall be established the following rates and charges for the use of the water and sewer system of the Village, based upon the amount of water consumed as follows:

**(A) WATER RATES-INSIDE VILLAGE LIMITS**

First	2,000 gallons per month	\$22.00 minimum charge
Over	2,000 gallons per month	\$12.00 per 1,000 gallons

**(B) WATER RATES-OUTSIDE VILLAGE LIMITS**

First	2,000 gallons per month	\$40.20 minimum charge
Over	2,000 gallons per month	\$16.07 per 1,000 gallons

**(C) SEWER RATES-ALL**

First	2,000 gallons per month	\$14.00 minimum charge
Over	2,000 gallons per month	\$5.85 per 1,000 gallons

**(D) STATE NPDES PERMIT FEE-ALL** \$0.68 minimum charge

**(E) BULK WATER SALES AT TANK** \$1.00 per 65 gallons

---

**SECTION 2:** Any other ordinances or provisions of the Revised Code of Ordinances of the Village of St. Jacob that are inconsistent with Section 1 shall be and are amended to conform

thereto. This ordinance shall become effective upon its passage, approval as required by law. The changes to rates will be assessed first during the June of 2026 billing cycle, and thereafter.
